- 5:30pm: Call to order for Regular meeting of the Board of Directors
- 5:35 Review and approval of May 3, 2022 meeting minutes
  - o motion to approve by clark, 2<sup>nd</sup> lucido, unanimous approval
- ADDITION to agenda: Draft fiscal control policy
- Zobs prepared to approve those, good timing with new auditor. Would entertain motion to adopt fiscal policied manual dated 5/2/22 so moved Bostick, 2<sup>nd</sup> colucci, all in favor, adopted unanmously
- 5:40 Treasurer's Report/Discussion of Financials Colucci new Treasurer
  - Colucci: likes the new format from H&H,

  - o why is 4400 memberships \$76k short?
  - o Zobs: we're largely being carried by expense savings. Keep an eye on spending
  - ZObs inclination is to defer on approving these in light of audit meeting and H&H turnover, Dave?

  - Jackson: The idea is to have questions from Finance and questions to and answers from Jackson before meeting
  - o Colucci moves to approve the financials, 2<sup>nd</sup> Zobs, discussion?
  - Lucido: just that the savings are best considered as a cushion
  - Zonbs calls for vote: passes unaniomously
